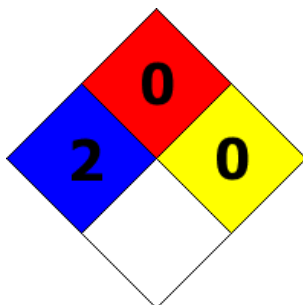

Extinguishing media

Suitable extinguishing agents:

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Protective equipment:

SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures:

Wear protective equipment. Transfer to a disposal or recovery container. Use respiratory protective device against the effects of fumes/dust/aerosol. Ensure adequate ventilation. Keep away from ignition sources.

SECTION 7: Handling and storage

Precautions for safe handling:

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air (i.e., clearing dust surfaces with compressed air). Avoid ingestion and inhalation. Avoid dampness. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Avoid contact with eyes, skin, and clothing.

Conditions for safe storage, including any incompatibilities:

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly sealed.
