# 3 – Hazards Identification

# **Emergency Overview: CAUTION!**

Eye irritant. May cause skin irritation. Inhalation of vapors or mists may cause nose, throat and upper respiratory tract irritation. Harmful if swallowed.

#### Symptoms of Overexposure:

**Inhalation:** Breathing of vapors or mists may cause irritation to the eyes, mucous membranes of the throat and nose and upper respiratory tract. Not recommended for use per persons with heart conditions or chronic respiratory problems.

Skin Contact: May cause irritation.

**Eye Contact:** Causes substantial but temporary eye injury with pain, tearing, swelling and redness. **Ingestion:** May cause irritation to the mouth and gastrointestinal tract. May cause abdominal pain, nausea and vomiting.

#### 4 – First Aid Measures

**Inhalation (Breathing):** Discontinue use and move to fresh air. Get medical attention if irritation develops and persists.
